By signing this form you are agreeing that:

- You are appointing St Catherine's Hospice Trading LTD to act as your agent on your behalf in attempting to sell or dispose of the goods that you donate. Where goods are sold, a commission of 1% of the sale price +VAT will be charged for this service and deducted from the proceeds of sale.
- You are a UK tax payer and would like to make a donation to St Catherine's Hospice and you would like all donations that you make, or have made in the last four years, to be treated as Gift Aid donations (until you notify us otherwise or this agreement is terminated). You confirm you are a UK tax payer and understand that if you pay less Income Tax and/or Capital Gains Tax than the amount of Gift Aid claimed on your donations in that tax year it is your responsibility to pay any difference.
