Job Summary: Secure new supporters on an individual basis via door to

door/venues promotion. To promote and recruit new members and all other products available in accordance

with budgetary requirements.

## Main Duties and Responsibilities:

- Actively sell and promote the full range of lottery products available, through locations directed by Head of Promotions.
- To develop lottery products within new and existing areas through door-to-door and local business venues.
- To work on such areas of income generation as directed by the Head of Promotions/Head of Finance.
- Maintain accurate records of calls and results as required.
- Comply with the FRSB code of conduct.
- To ensure that whether proactively or reactively, messages about the work of St Catherines are communicated positive.
- To ensure communication with supporters, potential supporters and



the general public is delivered in a positive and timely manner.

- Comply with the requirements of the Gambling Commission
- Complete all administration as instructed and in accordance with the rules and regulations.
- To report when necessary to review product development with Head of Promotions.
- To deal with queries from colleagues in relation to contacts made in the field.
